**Inside The Numbers**

When he wasn't being held or tackled, Moore landed 41 jabs. Lacy only landed 18 jabs along with 28 power punches. Unfortunately, this fight will be remembered not for the combat, but for the excessive holding. Both fighters were deducted points for holding in the 4th round after several warnings from referee Steve Willis. Lacy was deducted another point in the fifth round, and a third point in the eighth round- both for holding. Shortly after the third point deduction, Lacy tackled Moore, and both combatants tumbled out of the ring onto the announcers' table. Willis started counting, and Moore got back into the ring before Lacy. Willis ruled Moore the winner via disqualification at 51 seconds of the eighth round.
